Breakdown of online vs. in person donations

Breakdown in contributions for in person v online for March this only reflects the people who could be ID'd In person donated: \$1,464.31 online donated \$1,211.00. For April, in person people donated \$1,907.45 and online people donated \$1,883.00. Please note this number is not complete, some people couldn't be identified because they didn't indicate if they were in person or online.

The last time we donated was January.
